- ☐ FOR QUESTIONS OR TO SCHEDULE AN APPOINTMENT CALL 623-4564.

**Processing takes up to 8 weeks before being posted as a credit to your TPUD utility account. Please do not call to check on the status of a rebate until after at least two billing cycles.**

**HELPFUL FILING TIPS:**

HVAC rebate documents should include signed and dated contract, contract or invoice with all requested equipment information; (make, model number, ARI #, HSPF2, and SEER2).

## **ELECTRIC HEAT PUMP REBATE (5 Tons or Less)**

<b>All Units that Meet Rebate Criteria as Described Below</b>
Heat Pump Incentive
\$1,000 /Unit

### **Electric Heat Pump Rebate Criteria**

1. Electric Heat Pumps (split system) with Seasonal Energy Efficiency Ratings (SEER2) of 14.3 or greater and Heating Seasonal Performance Factor (HSPF2) of 7.5 or greater are eligible for a rebate.
2. Package Units with Seasonal Energy Efficiency Ratings (SEER2) of 14.2 or greater and Heating Seasonal Performance Factor (HSPF2) of 6.7 or greater are eligible for a rebate.
3. TPUD must pre-approve your rebate if more than one unit is installed in a new residence.
4. Heat Pump rebates are available for both new construction and retrofit/replacements. All rebate applications require supporting documentation, including: unit specifications with ARI Reference number.
5. ARI#'s must be verifiable on the current AHRI directory, numbers that have been removed may not qualify.
6. Submittal for rebate must be accompanied with a copy of the Trinity County Building Permit signed off by the County Inspector, and where applicable, with CF-1 and CF-6 documents.
7. Installation of heat pump by qualified contractors only.

### **Commercial Projects**

1. Commercial projects need to call for pre-approval at 623-4564.
2. **Rebate dollar maximums are for the life of this program.**

**NO INSTALLATION REBATES WILL BE AWARDED WITHOUT  
A TRINITY COUNTY BUILDING PERMIT AND SUCCESSFUL FINAL INSPECTION.**
