Lewiston Project

Mr. Hauser stated that he is making progress on the revenue enhancement and cost savings efforts. He has a verbal agreement with the City of Redding and RTA is working on ways to cut some construction costs. The Bureau is also in agreement that the District can own the facilities, however there is still some concern regarding extending the Lease of Power Privilege.

There was discussion regarding the Delta Reform and how the Lewiston Project could be affected.

Mr. Hauser stated that he will be speaking with the Trinity County Board of Supervisors in August regarding the River Restoration and the Lewiston Project.

Land Exchange

Mr. Hauser informed the Board that the appraisals are nearly completed for the property involved in the land exchange. He also stated that he anticipates the Bill to be moving from the House to the Senate within the next couple of weeks.

Website

Mr. Hauser advised the Board that Director Gant provided assistance with the outline and navigational structure for the Website. This information has been provided to Peter Griggs. Staff is gearing up to provide content to Peter for inclusion on the Website.

Power Outages

Mr. Hauser reported to the Board that the District had two outages over the last month. The first lasted approximately 40 minutes and it affected a portion of Weaverville, including the Tops complex. This outage was caused by a Locust tree limb breaking and falling on the electric line two spans from the Mill Street Substation.

The second outage was caused by a Digger Pine breaking and falling through the electric lines in Big Flat. This outage occurred at 8:15 p.m. and power was restored around midnight.

Mr. Hauser also discussed the significant number of outages that the lineman respond to that are because of a customer's breaker. Mr. Hauser was directed to address this issue at a future Board Meeting.

Community Choice Aggregation

Mr. Hauser stated that Trinity County Supervisor Wendy Otto has been meeting with community members and will be making a presentation to the full Board of Supervisors about the Voluntary Community Choice Aggregation District concept. She has requested that Mr. Hauser attend the Board of Supervisor's meeting in September to assist with the presentation.

CalPERS Review

Mr. Hauser informed the Board that CalPERS has contacted Staff and has scheduled a review of the District's CalPERS Contract and the information that the District is reporting. He stated that he feels this is a positive step to insure that the District is providing correct information to CalPERS.

Western Refund

Mr. Hauser advised the Board that the District has received a refund of \$94,050 from Western. This refund is because Western has continued to bill the District for Scheduling Coordinator Services since October 2010 even though BANC had taken over this responsibility.

• Late Payment Policy

Mr. Hauser informed the Board that the current Utility Billing Delinquency, Late Payment, and Disconnections Policy requires Staff to call customers regarding a past due balance on their electric account. Staff is regularly calling approximately 350 customers a month, and some of those customers more than once. He also stated that the vast majority of these customers are frequently on the Disconnect List every month. The Board directed Mr. Hauser to address this at a future Board meeting.
