c. Award Bid 14-B5 Fire Mitigation Right-of-Way Clearing

Mr. Hauser reviewed the Report with the Board. He stated that this bid was not only to restock the District's inventory, the majority of the conductor will be used in the Long Canvon Project. He mentioned to the Board that the bid amount is lower than the last time we went out to bid. He also stated that the low bidder is a reputable company and the delivery time is much quicker than any of the other bidders.

Approve Purchase of Line Construction Truck with Digger Derrick

6. **Discussion Items**

a. Communication Philosophy

Mr. Hauser requested direction from the Board regarding a possible policy addressing participation in social media. He mentioned that he is hesitant to participate in social media because it could potentially take up a lot of Staff time.

After a brief discussion the Board stated that the General Manager should be the only individual responding on behalf of the District to comments made in the newspapers and social media.

They Board requested Staff to provide them copies of the Policies that pertain to Board Members.

b. Board Meeting Locations

Mr. Hauser requested feedback from the Board on when, and if, they would like to schedule meetings in different areas of our service territory again.

The Board agreed that in the spring we should schedule one meeting in Hayfork, one in Trinity Center, and possibly one in Lewiston and the down river area.

The Board suggested that an ad hock committee be formed to meet with the General Manager to prepare a presentation on water issues and how they affect power costs. This presentation would then be presented prior to the April Board meeting in Weaverville followed by each meeting in the different locations. It was also suggested that the presentation be available for viewing on the website.

7. Reports

a. General Manager's Reports

Trinity Adaptive Management Working Group Meeting
 Mr. Hauser informed the Board that there will be a joint meeting with the
 Trinity Management Council and TAMWG on the 30th and 31st of this
 month.

Long Canyon Project

Mr. Hauser reported to the Board Bill Sharp has completed Stage I of the project and did an excellent job. He also stated that once the 25kV conductor has been delivered both line crews will begin installation of the main line. Shortly after that we will begin connecting individual services.

The installation in the Mountain Aire Subdivision portion of the project will likely begin in the spring. Mr. Hauser stated that this stage of the project will be a little more difficult. He also mentioned that Staff sent out letters to approximately eight property owners in the subdivision requesting easements to complete the project.

Land Exchange

Mr. Hauser informed the Board that there is still an attempt to get the land exchange bill passed through the House. At this point, it is too late to introduce it in the Senate.

Mr. Hauser mentioned that he and Dave Myers have again discussed a direct land exchange with the Forest Service.

The Board concurred that the District should continue to pursue both options.

Power Outages

Mr. Hauser informed the Board that there were two significant outages that occurred since the last meeting. The first one occurred in the Roundy Road area and affected approximately 100 customers and lasted almost four hours. The outage was caused by a customer cutting down a tree that was previously marked as a leave tree as part of the Forest Service Timber Sale. The Forest service has a suspect and is pursuing prosecution.

The second outage affected the east side of Weaverville and Timber Ridge area when a guy and anchor broke along Highway 299. This outage affected close to 200 customers and lasted approximately one hour.

Mr. Hauser mentioned to the Board that the District may receive a claim from a customer who experienced an extended outage in the Buckhorn area.

Lewiston Project

Mr. Hauser informed the Board that he was able to tour the existing Lewiston Power Plant. During this tour he noticed that the pin stock serving the existing plant is possibly big enough to handle a larger power plant. He stated that he is reviewing the Black and Veatch study from 2001 to see if there is any indication that the pin stock is adequate.

Mr. Hauser also mentioned that the City of Redding is no longer interested in purchasing the additional power from the District. He will be in contact with other Western customers to determine if there is any interest in purchasing the power.

Community Land Trust

Mr. Hauser informed the Board that he has been contacted by Mr. Jerry Cousins regarding using a portion of the Weaverville property for a Community Land Trust. This would make lower cost housing available. He explained that the trust would maintain ownership of the land while allowing individuals to own a residence on the land.

Western Customer Meeting

Mr. Hauser reported to the Board that Western reported that as of September 30th the generation for Fiscal Year 2014 was 2,800gWh which is a lot lower than the normal 4,800gWh. They also reported that the water storage was 2.8 million acre feet, which is also much lower than the normal 6.1 million acre feet.

Mr. Hauser also stated that the Bureau is working on the Trinity Runner Project, replacing one unit at a time. He also informed the Board that the Bureau is also rewinding a unit at Spring Creek.

Weber Flats Hydro

Mr. Hauser informed the Board that Mr. Dave Peluchi recently contacted him regarding the Weber Flats Hydroelectric Plant. During their discussion, Mr. Hauser mentioned that the District might be interested in purchasing the plant.

Mr. Dale Miller arrived at 3:40 p.m. to clarify the Board's questions regarding the Hyampom transmission line and the Big Creek Hydroelectric Plant.
