# 4. Public Input

# a. Rate Restructure

Ms. Theresa Vess addressed the Board regarding the Rate Restructure. She stated that the System Access Fee is not fair. She stated that someone at the front desk told her it was to allow her to access the computer. She also wanted assurance that the District's rates were still lower than Pacific Gas and Electric. President Gant explained the reason for the System Access Fee and assured her that PG&E's rates were more than double then the District's rates

#### b. Adopt Resolution 15-08 Amending Rate Schedule 11, Unmetered Services

Mr. Hauser informed the Board that the Resolution number is incorrect. The Board adopted Resolution 15-07 last month when the Commercial Rate Schedule was changed. This Resolution should be 15-08.

Mr. Hauser reviewed the Report with the Board. He explained that Velocity Technology's internet services have the majority of the devices that are on the Unmetered Services Rate Schedule. PG&E has been installing an automatic switch for the Big Flat area which will also be on this Rate Schedule.

#### 7. Reports

- a. General Manager's Reports
  - Trinity Adaptive Management Working Group Meeting Mr. Hauser reported to the Board that Ms. Robin Shrock, the Director of Trinity River Restoration Program, has resigned.

#### Land Exchange

Mr. Hauser informed the Board that there has been progress with the Land Exchange. He has a meeting with Ms. Irwin from the Forest Service tomorrow to discuss the archeological survey. He also stated that because the District has no plans to change anything on the property it will qualify for the lowest level of the National Environmental Policy Act (NEPA).

#### Power Outages

Mr. Hauser reported that there has been only one significant outage since the last Board Meeting. One of the three 60 kV switches at the Hyampom Substation burned up. Two of the three switches have been replaced in the last few years.

#### Lewiston Project

Mr. Hauser reported that the bad relay at Lewiston 350 kW Generator has still not been replaced. He reminded the Board that the relay needs to be replaced in order to test the pen stock.

## Lewiston Transformers

Mr. Hauser informed the Board that the four new transformers have finally all arrived, however there are still some missing parts. He stated that Staff has completed the test for the load transfer so now the only concern is the weather. It is necessary to have a week of clear weather to replace the transformers.

Mr. Hauser also informed the Board that when they approved the bid for the transformers, Staff was anticipating having to pay the sales tax on the quarterly Use Tax Return. He stated that General Pacific has included the sales tax on the invoice and the transformers came in under the approved amount.

# Balancing Authority of Northern California

Mr. Hauser reported that there continues to be a lot of activity.

#### California Independent System Operator Symposium

Mr. Hauser informed the Board that he attended the CAISO Symposium. A panel that was comprised mainly of European companies expressed the need for higher energy costs to support the integration of intermittent resources.

Mr. Hauser explained to the Board that the energy costs from Western have increased from \$0.018 per kWh in October of 2011 to \$0.0423 per kWh for October 2015.

#### Community Choice Aggregation

President Gant requested an update regarding the Community Choice Aggregation (CCA). She stated that the County CAO has informed her that the District is holding up the process. Mr. Hauser informed the Board that the District is still waiting for the paperwork from the County to obtain the information required from PG&E.

#### Shaded Fuel Break

Director Rose stated that Six Rivers National Forest has almost completed the Nation Environmental Policy Act (NEPA) to allow the salvage logging to begin in the burn area.

#### Firewood Processing Plant

Director Rose reported to the Board that he attended the presentation at the Firewood Processing Plant in Hayfork. Mr. Jim Jungwirth expressed gratitude to the District for the installation of the electric service.

#### Hospital

There was discussion regarding the optimistic presentation from Mr. Aaron Rogers regarding the hospital finances. It has been reported that the hospital is becoming financially solvent.
