a. General Manager's Reports

Trinity Adaptive Management Working Group Meeting
 Mr. Hauser informed the Board that there has not been a meeting and that TAMWG has been permanently suspended.

Land Exchange

Mr. Hauser reported that he has spoken with Mr. David Myers requesting that the Land Exchange be concluded prior to the end of the year. He also informed the Board that Mr. Joe Smailes from Quincy will be the new District Ranger in Weaverville.

Power Outages

Mr. Hauser informed the Board that the only large outage since the last Board meeting was in the Trinity Center/Coffee Creek area. The outage affected approximately 592 customers and lasted a little over three hours.

Balancing Authority of Northern California

Mr. Hauser stated that there is still nothing to report at this time.

District Refinancing

Mr. Hauser stated that Ms. Catanese and Ms. Palmer did the majority of the work on this endeavor. The outcome is a \$2.58 million savings for the District.

Update on New Meter System

Mr. Hauser reported that the District's staff is pleased with the results from the first 292 meters that have been installed. The only problem is that the new meter system is interfering with the old system reporting in Weaverville.

Not on the Agenda

Satellite Communications

Mr. Hauser reported that he was able to attend a demonstration of a GPS/Satellite communication system. This system would allow field staff to isolate outages sooner and to maintain contact with District vehicles. The system could be used in substations where there is no internet service or cell phone service. It will assist in radio communications in area's where there is poor coverage.

Watershed Center Request

Mr. Hauser reported that the Firewood Processing Center has closed, however, the Watershed Center will continue to pay the loan.

Mr. Hauser stated that the Watershed Center is now requesting that the District's Community Investment Program assist in providing power to the peeler shed. The cost of this assistance is estimated at \$40,000. The Board suggested that the District not approve the request until the loan for the Firewood Processing Center is paid in full.

Electric Services to Large Load Customers

Mr. Hauser stated that he has discussed concerns with County Supervisor Groves regarding the influx of requests for large electrical services. He stated that the District's current electric infrastructure is not capable of supporting a large number of these services. He stated that he will be setting up a meeting with Supervisor Groves and Morris to discuss this further.

Golden State Power Cooperative

Mr. Hauser informed the Board that he has been contacted by the Manager of the Golden State Power Cooperative. She wanted to inform the District that their Board has agreed to include public agencies into the cooperative as associate members. Mr. Hauser explained the benefits to the District of joining this cooperative.

Drones

Mr. Hauser informed the Board that the District is in the process of purchasing a Drone. The device would be used to patrol line for outages, maintenance, and tree trimming purposes. Mr. DeLange, the District's Vegetation Program Manager, has obtained a rural industrial pilots license.
