Mr. Hauser reviewed the Report with the Board. He reminded the Board of some of the confusions associated with the declaration of a low water year and implementation of the Drought Relief Surcharge. There was discussion regarding changing the name of the charge and the impact it causes on the District's reserve policy. The Board suggested striking the word "all" regarding the applicable customers. The Board also suggested defining the Bulletin 120 report by adding Statewide. The Board also suggested removing Special Conditions 1 since it is not applicable any longer.

a. General Manager's Reports

Land Exchange

Mr. Hauser spoke with a company from Shasta Lake City who will be providing a proposal for the hazardous material assessment. After the assessment has been completed and reviewed, the District will decide whether or not to move forward in obtaining the appraisal.

Power Outages

Mr. Hauser reported to the Board that on March 22nd the District experienced numerous outages due to a storm. The largest of these outages was in Weaverville affecting 550 customers and lasted a little over an hour.

There was another outage in the Coopers Bar area in Junction City that was caused by a tree on the line. This outage lasted about five and a half hours and affected 125 customers.

The Buckhorn area experienced an outage that affected 42 customers and lasted about four hours. This outage was caused by a tree on the line also.

Balancing Authority of Northern California

Mr. Hauser stated that there is nothing new to report. The California Independent System Operator is encouraging utilities to join the Energy Imbalance Market.

National Rural Electric Cooperative Associations Legislative Meeting
 Mr. Hauser stated that he and Ms. Susan Stohr attended follow-up meetings regarding shaded fuel breaks and vegetation management.

Mr. Hauser stated that participating with Golden State Power Cooperative (GSPC) was very good. GSPC reaches out to a lot of legislators who may or may not represent all of the different entities.

New Meter System

Mr. Hauser informed the Board that there are about 2,500 TWAC's meters installed. He also stated that the District will participate in the beta application for the new handheld units. They should be arriving next week.

District Website

Mr. Hauser stated that Ms. Palmer has sent all of the policies and rate schedules to Atomic 8 Ball for the secure login. Hopefully by the next meeting the secure login will be operational.

Wildfire Legislation

Mr. Hauser reported that Senate Bill 901 will require all utilities to develop criteria to de-energize electric lines during high fire danger. He will be attending a meeting regarding this in San Diego next month.

Trinity County Ambulance Company

Mr. Hauser informed the Board that the Trinity County Life Support is attempting to become a special district which would enable them to obtain certain grants. It would also increase the amount they could receive from Medical and Medicare.

Excavator Purchase

Mr. Hauser informed the Board that one of the major purchases that Staff will be requesting in the next budget year is an excavator. The cost will be approximately \$75,000. He stated that within the last year it has been difficult to obtain assistance from local contractors because they have been very busy.
